

# **Daikin Spring 2021 Ductless Rewards Consumer Program**

# Consumer may receive up to \$1000\* Rebate with purchase of qualifying Daikin Ductless equipment\*\*\*

### **Promotion overview:**

Dealer will be eligible for an Instant Rebate to the homeowner for qualifying ductless equipment under the EGIA program.

# Daikin Spring 2021 Ductless Rewards Consumer Program - INSTANT REBATE\*

#### Eligible Participants (Daikin ductless dealer/Homeowners) and Timing:

This program is eligible for participating independent Daikin ductless dealers with a signed dealer agreement.

- Homeowner must purchase equipment between March 1, 2021 and May 31, 2021.
- Dealers must install between March 1, 2021 and May 31, 2021.
- All consumer rebate claims must be submitted by June 15, 2021.
  - Late claims will be paid out at 50% of the dealer rebate amount per the Consumer Rebate Matrix only for a short period after the initial deadline. Any late claims will be paid at Daikin's discretion.
- Eligible sales may not be combined with other rewards program offers

#### Qualifying Daikin Equipment\*\*\*

- To qualify for the Daikin Spring 2021 Instant Rebate, Homeowner purchase invoice must include:
  - NV Series, FTXR09TVJUW/S, FTXR12TVJUW/S & FTXR18TVJUW/S, LV & FDMQ Series, Aurora/Vista, MXS/MXL & SkyAir
- See Consumer Rebate Matrix for full details.
- Complete systems required to be eligible for consumer rebate

## <u>Daikin Ductless Dealer Responsibilities for Consumer Instant Rebate</u>

- Daikin ductless dealer is responsible for 33% of each consumer instant rebate amount, but will need to provide the full rebate to the homeowner at time of purchase. Daikin ductless dealer will claim back 66% of the total rebate from Daikin post sale.
  - o E.g.: If a homeowner instant rebate is \$450, Daikin ductless dealer will receive a rebate from Daikin (via EGIA) for \$300.
- Daikin agrees to reimburse the Daikin ductless dealer, via payment from EGIA, for any claim that EGIA determines to be valid.
- Daikin will invoice independent distributor participants 33% of each consumer instant rebate amount via Rebates Automation.
- Daikin ductless dealer may not apply any Daikin marketing accrual funds for repayment of consumer rebates.
- Daikin ductless dealer should **not** increase their invoice price by the price of the consumer instant rebate and all invoices should clearly denote the instant rebate provided.

## Claims process

- Dealer will file the rebate claim with EGIA, including all necessary documentation, at <a href="https://www.egia.org/daikin">www.egia.org/daikin</a>. Program portal will be available March 1, 2021.
- All claims must be submitted online by the dealer with appropriate back-up documentation.
- Rebate claims must be submitted before June 15, 2021 at the latest.

- Daikin ductless dealer must provide EGIA with <u>ONE</u> of the following for the online claim:
  - A copy of their invoice including:
    - Invoice number
    - Serial and model numbers for all equipment purchased
    - Homeowner name and address



- Date of installation
- Rebate given to homeowner
- Daikin ductless dealer name and dealer number (local distributor number)
- A copy of the Daikin product registration confirmation
- If homeowner invoice does not include equipment serial numbers, Daikin ductless dealer must provide a copy of warranty registration number with serial numbers.
- Allow 4-6 weeks for rebate processing and receipt of rebate check.
